# Lucas - 3 Chest Compression System

Mr. Brandon McDowell requested approval from the Board for \$19,000.00 that will allow portable use of the system for precise/efficient chest compression, adjustable for the patient and allows dual purpose for the person doing the compression and less harm to the patient. He stated the Consolata HealthCare Foundation will pay half the cost with CMMC. Discussion ensued by the Board.

Mr. Brandon McDowell stated this nerve detection unit allows the surgeon to make precise cuts on the patients and avoid damaging hard to see nerves. The cost of \$28,000.00 for purchase. Stated the Consolata HealthCare Foundation might incur half the cost with CMMC.
